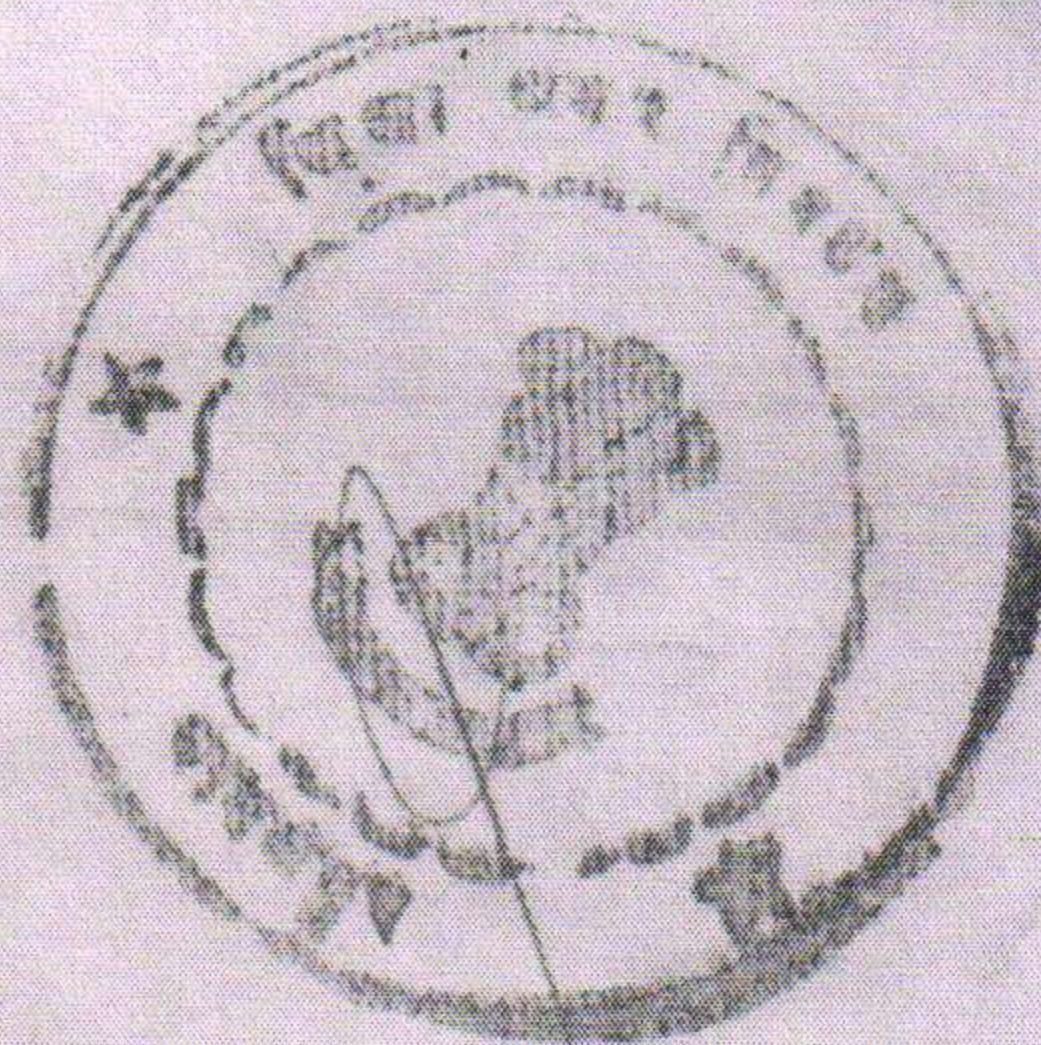



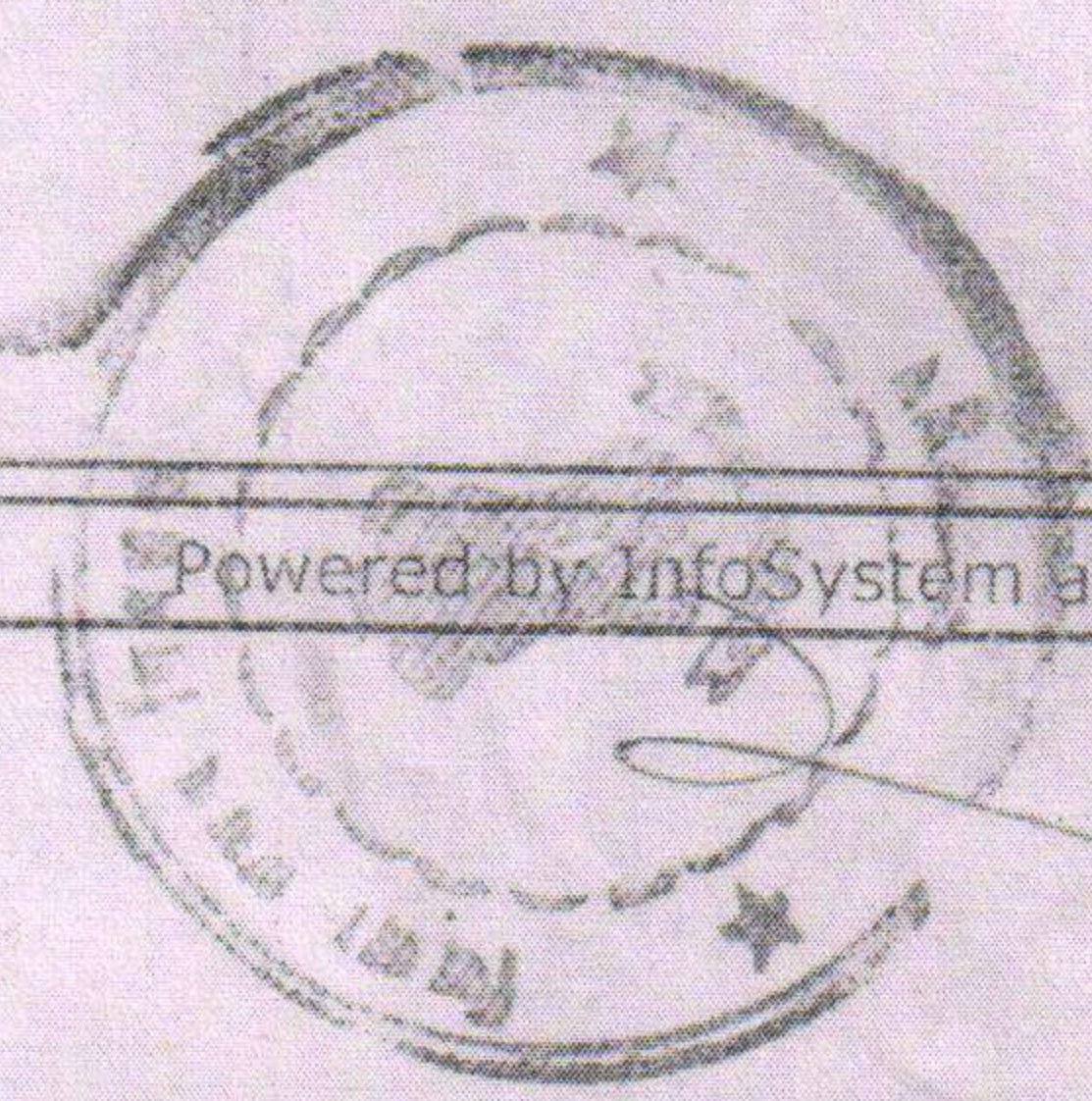

- iii. The Institution is being organized for the promotion of Spiritual, Physical, Mental, educational and

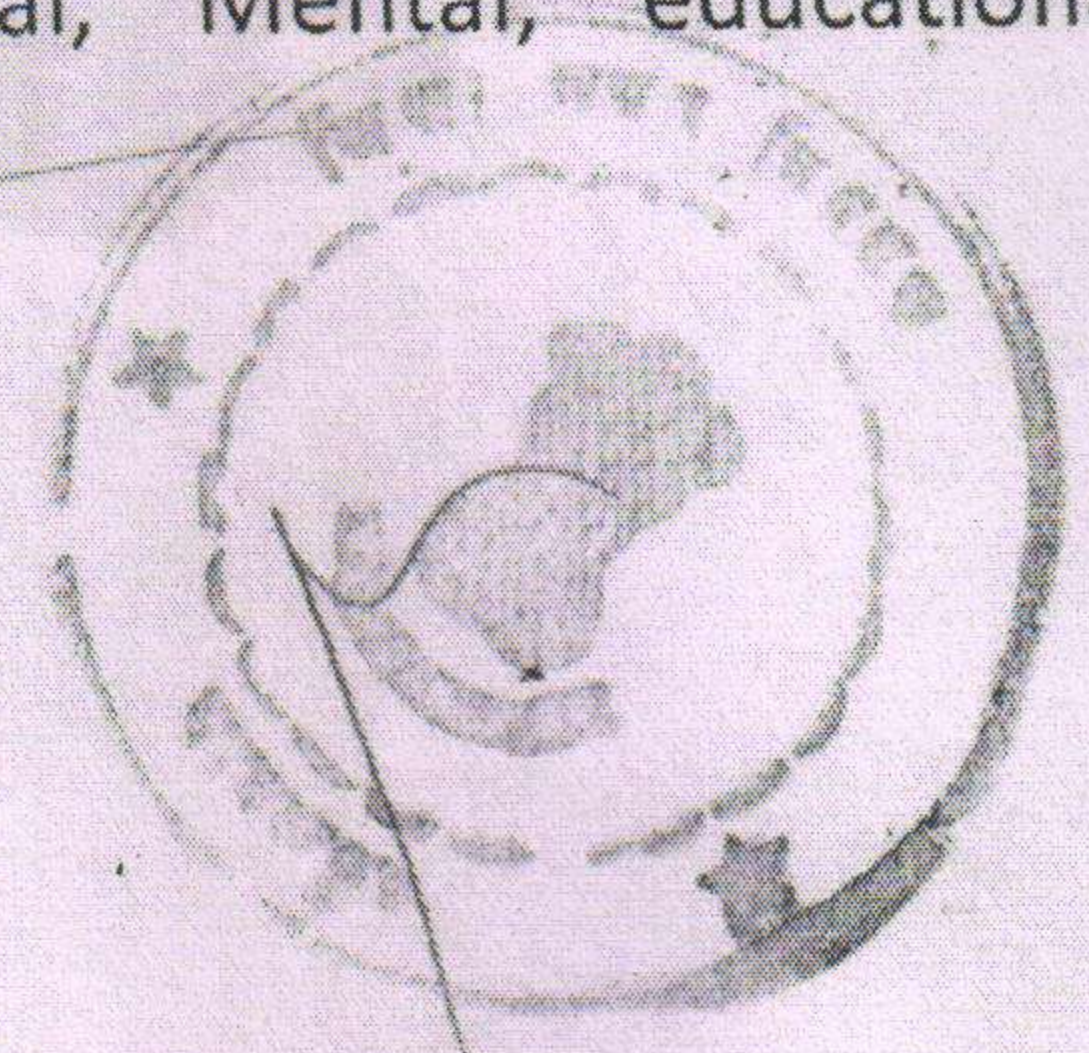





- vi. To work environmental up gradation and make people aware of the ecological balance of Nature on priority basis in view of alarming global environmental degradation.

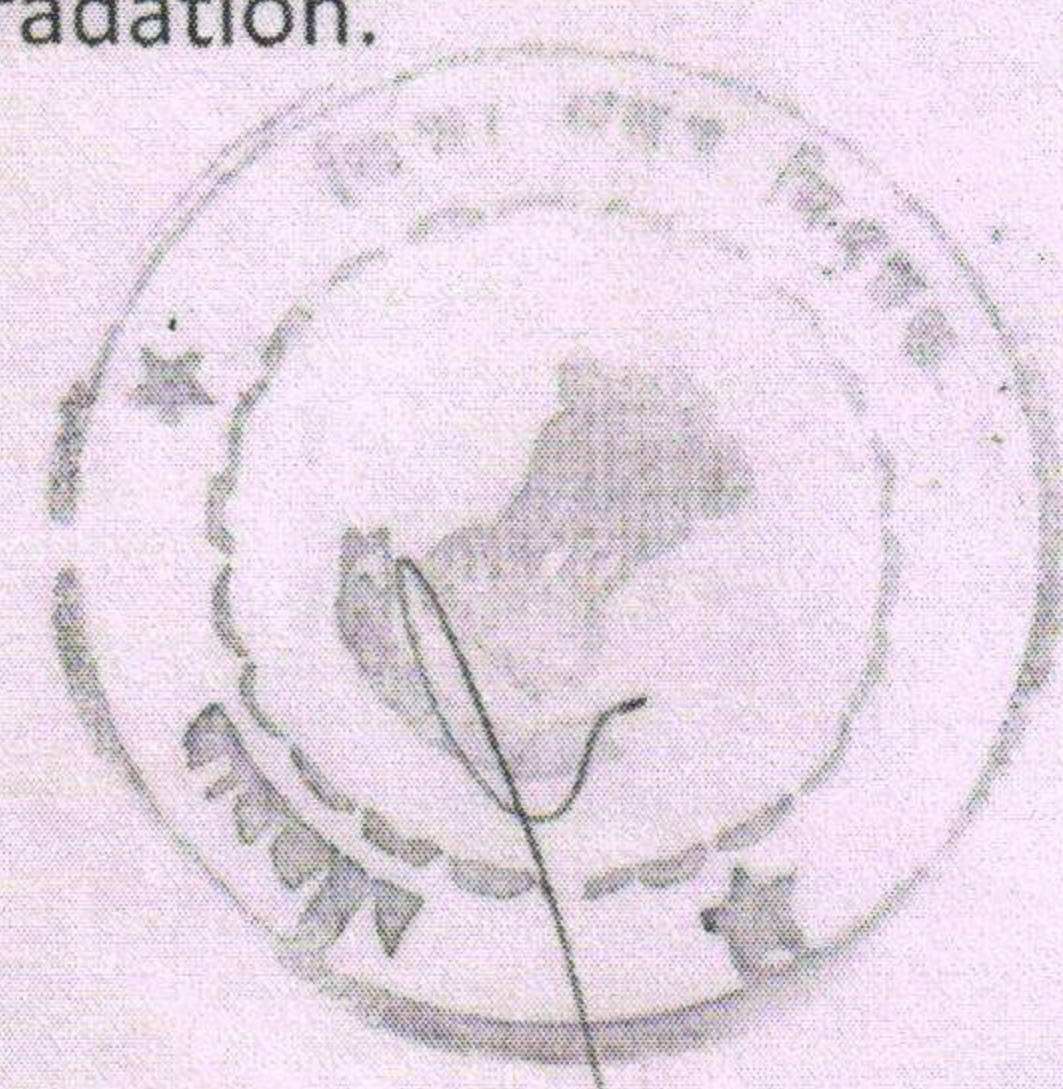

- b) The management, control of the property and affairs of the Trust aforesaid shall be vested in the Managing Trustee with full powers and authority to purchase or hold any land or hereditament and construct any building for the object of the Trust or any funds or any other properties of investment at any time, subject to the trust of these presents. It shall be lawful for the Trustees from time to time to frame such rules and regulations for the management and administration of the Trust and charities as they deem fit and to alter or vary the same from time to time, make new rules and regulations provided such rules and regulations shall not be inconsistent with the terms and intents of these presents and not inconsistent with the relevant provisions of the Income tax Act. 1961

- c) The Trustee shall meet as often as possible but not less than three times in a year for efficient management of the Trust to consider the income and

d) A resolution in writing circulated amongst all the Trustees and signed by a majority of the Trustees shall be as valid and effected as if it had been passed at meeting of the Trustees duly called and convened.

e) At all meeting of the Trustees sixty percent members shall form quorum.

f) At all meeting of Trustees the Managing Trustee shall preside over all meetings and in absence of Managing Trustee the Trustees shall, with the oral consent of the Managing Trustee, choose a Trustee from among those present to preside over such meeting.

g) All proceedings of the meeting of the Trustees shall be recorded in a Minutes Book kept for the purpose.

h) In case of any difference of opinion between the Trustees in any matter connected with the Trust and its administration the decision of the majority will be final and binding on all the Trustees. In the event of equality of

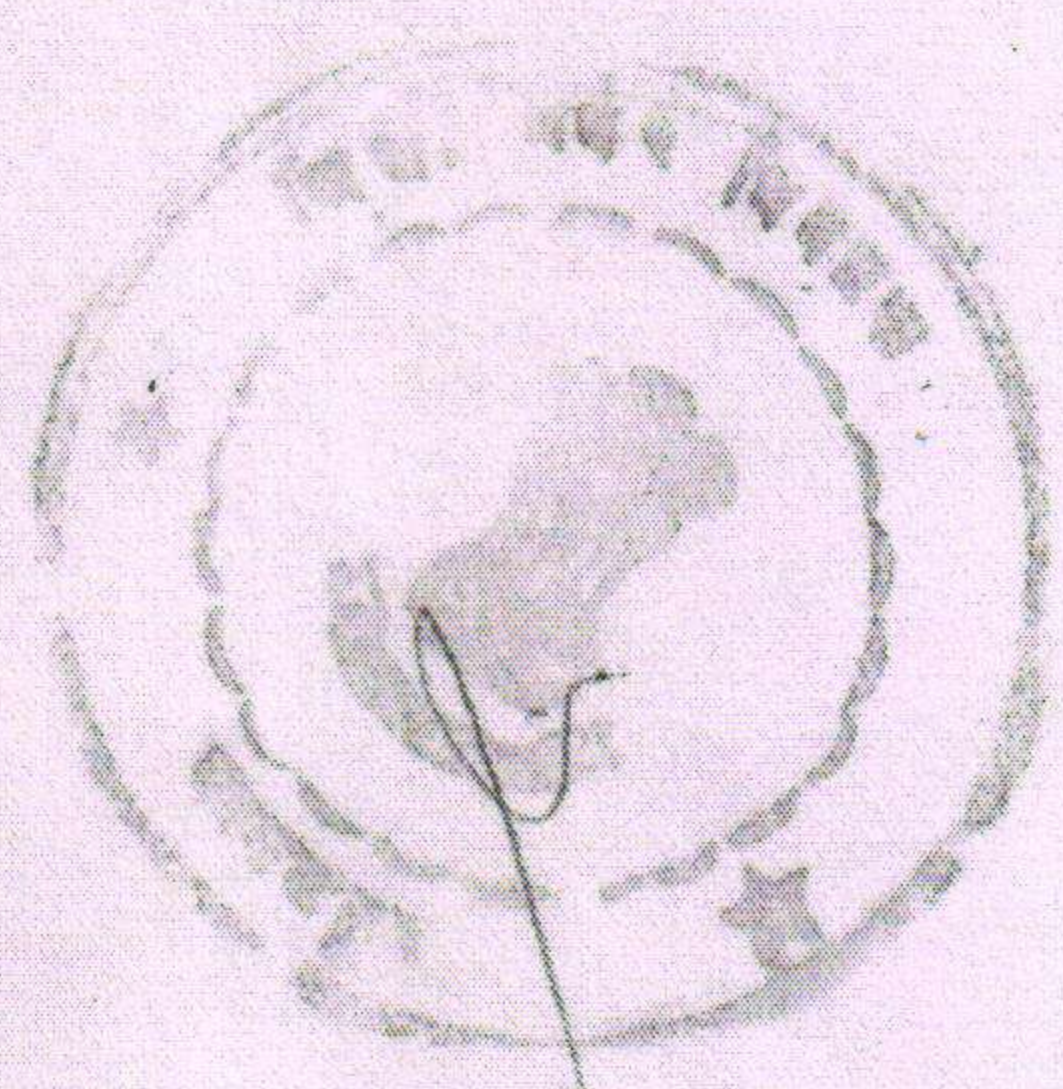

6. POWER OF TRUSTEES:

- a) To manage Trust Funds and collect and recover the interest income and profits thereof and to pay thereout the expenses of collection and other outgoing, if any

- c) The Trustees shall be entitled to resolve from time to time to open, maintain and operate a Bank account or accounts in the name of the Trust at such bank or banks as they may from time to time decide and may at any time pay or cause to be paid any monies forming part of the Trust Fund or the income thereof to the credit of any such account or any other account. Any such account shall be operated/opened jointly by Managing Trustee and one more Trustee elected by the board of trustees.

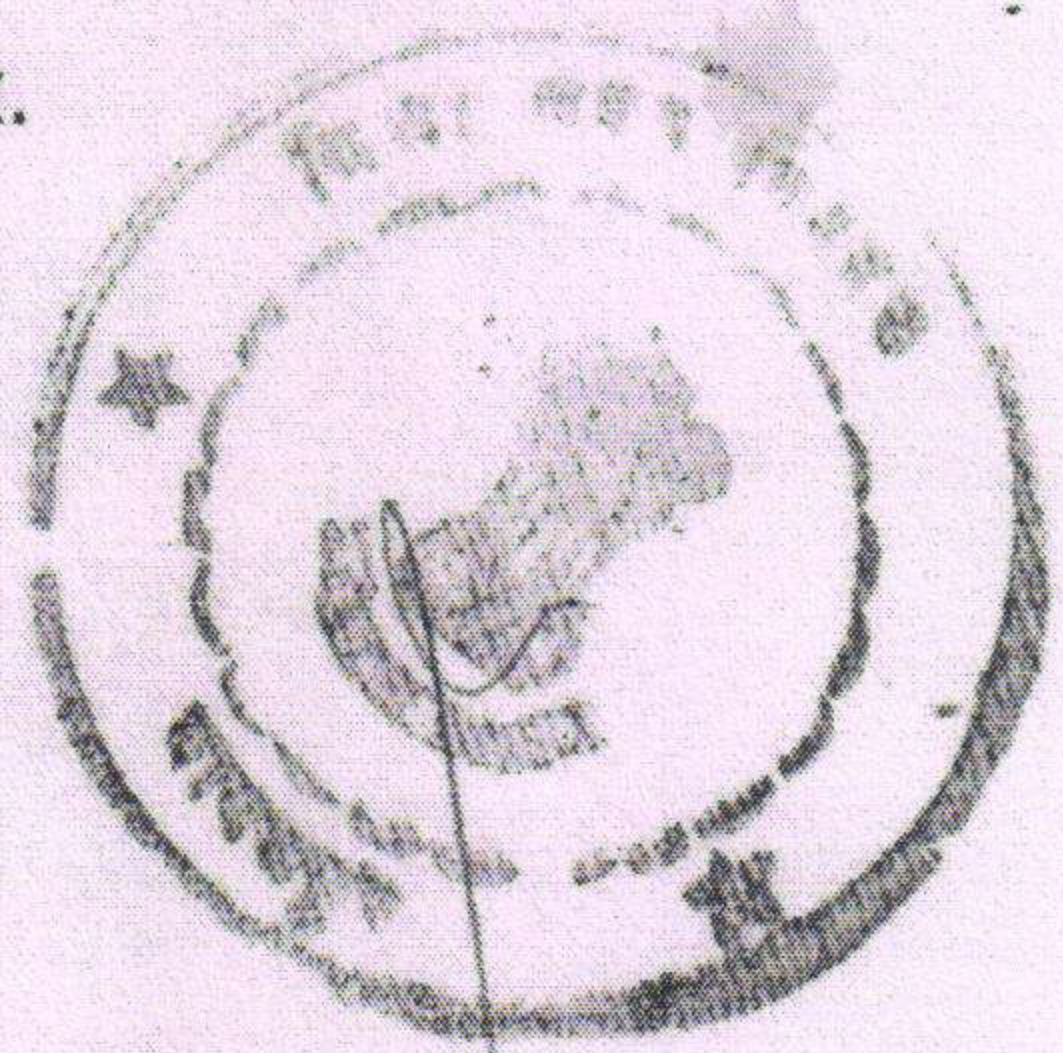

g) Proper accounts showing all receipts and disbursement made on account of the Trust hereby constituted shall be kept by the Trustees who shall prepare receipts and payment account, income and expenditure account and balance sheet as on March 31st every year and shall be duly audited by a qualified Chartered Accountant.

h) The Board of Trustees shall ensure that any dues to the government by way of taxes, levies, cesses or any other charges are paid first out of the Trust Fund before meeting any other expenses related to the Trust.

i) The Trustees may from time to time appoint any accountant, clerk and other officials and employees, including any trustee, as the trustees may deem expedient, and fix and pay their remuneration out of the Trust Fund or the income thereof.

j) To establish ad hoc committees/groups for activities to meet any of the objects of the Trust

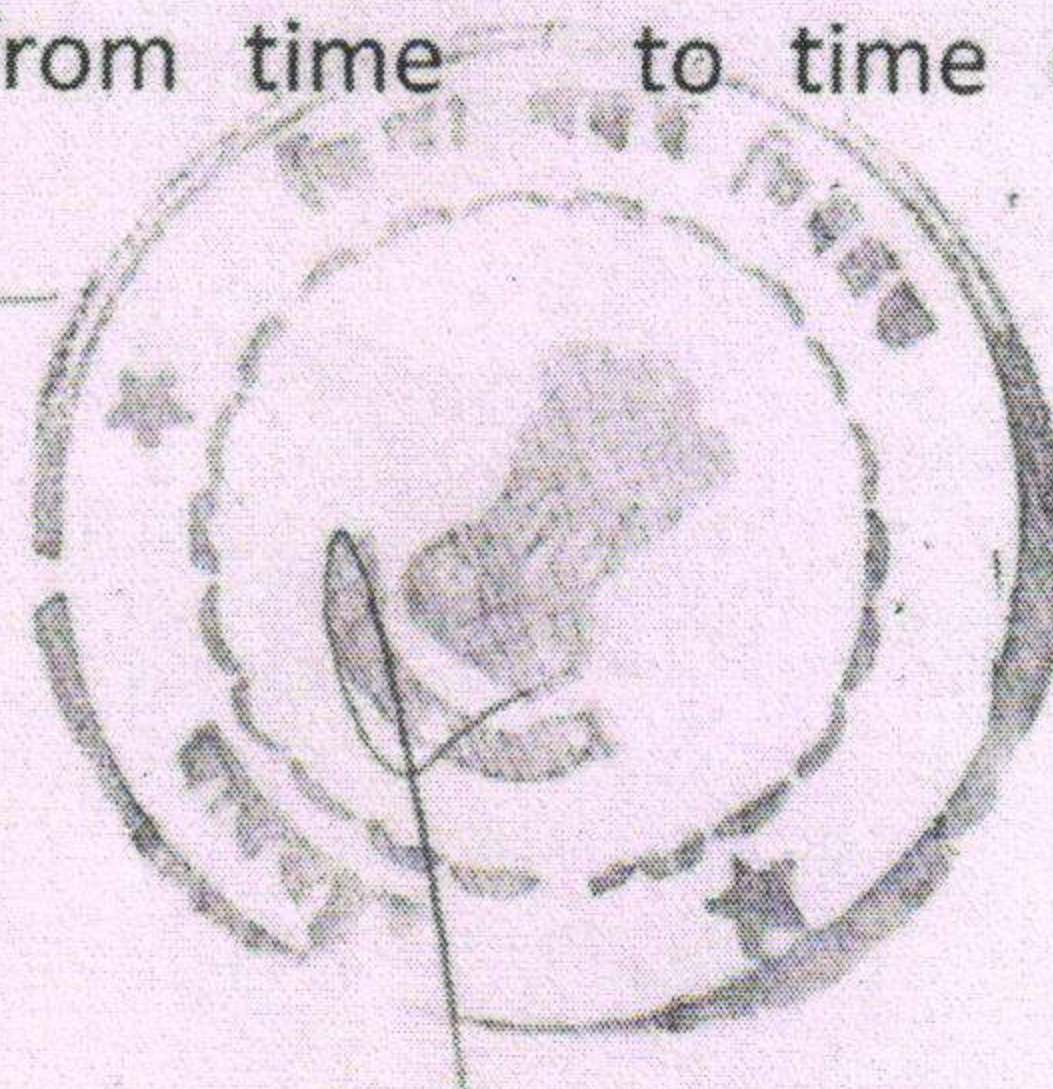
